Students who wish to be enrolled in the Sport events, can give his/her name to the respective class teacher on 2nd June 2025

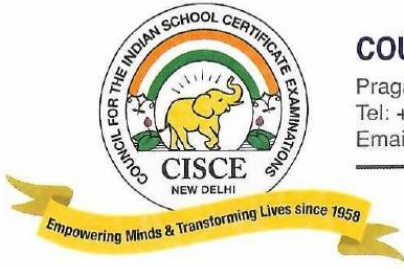
The Student must submit the following documents:

3. Copy of the final marks card from the last academic year,
4. Student's school ID card, and
5. Duly filled & signed undertaking form

All the above documents **must be submitted** to the Physical Education teacher - Mr Ananda Kumar on June 3, 2025.

IMPORTANT NOTE: this activity only for registering students in the council for different sports events. The PE Teachers will select students at school before they can join a specific sport or event. Only those who qualify will be allowed to participate.

Dear Principal,

This is with reference to our circular no. CISCE/Sports/2025-26 dated April 1, 2025 regarding “CISCE Games & Sports 2025”, wherein it was made mandatory for students to have an insurance to participate in CISCE Games & Sports 2025 at **all levels** of competition. However, CISCE has been receiving several requests from schools, parents and students to allow participation at the **zonal level** without insurance.

In light of the above, it has been decided to permit participation of students at the zonal level without submission of medical/accidental insurance policy upon submission of an **undertaking from their parents duly countersigned by the School Principal** in the enclosed proforma.

4. Compliance:

We ensure that the child's/ward's follows all rules, regulations, and guidelines established for the smooth conduct of the competition.

5. Indemnity:

We agree to indemnify and hold harmless CISCE and the host school from any and all liability, claims, damages, or losses arising from the child's/ward's participation in the CISCE Zonal Level Games & Sports competition.

6. Medical Emergencies:

In the event of a medical emergency, we agree that we will be responsible for arranging and paying for any necessary medical care and transportation for the child/ward.
